## Note to warranty and repair application

For warranty and repair handling, Van der Ende Group apply the Metaalunie conditions (to be downloaded via [www.vanderendegroup.com/service/warranty-returns](http://www.vanderendegroup.com/service/warranty-returns) or provided by mail upon request). In addition, the following conditions apply:

### General

- Please fill out the tables as completely as possible;
- The completed form should be attached to the outside of the (transport) packaging in a prominent way;
- Failure to submit a completed WRA form, with the declaration of health and safety may lead to a delay in handling;
- The product/products are delivered to our premises by you and for your account;
- The products should be properly packed for transport;
- In case of repaired products, our standard schedule for transport costs apply.

### Repair

- If (after a quote has been submitted) no repair takes place and a new/replacement product is not bought from us, we will charge a minimum of €54,00 for inspection, plus applicable transport costs;
- If we have not received approval for repair within 4 weeks from the quote, the products will be returned to you in a non-repaired (and possibly dismantled) condition. This procedure will automatically entail an invoice for inspection costs plus transport costs;
- The above procedure also applies if failures are established.

### Warranty

The general rule states that Van der Ende Group will not pay any transport/replacement/installation costs for the defect products. When we offer you a new product at no charge, this goes under the condition of approving the warranty. If the warranty can not be granted, you will receive an invoice of the product already received.

- Article 14 of the Metaalunie conditions is used as a basis for granting warranty;
- Warranty will not be granted for defects resulting from:
  - Changes which are implemented by the client/ byer or third parties without the approval of Van der Ende Group;
  - Normal wear;
  - Improper use;
  - Insufficient maintenance or incorrect repair by others than Van der Ende Group;
  - Failure to comply with the operations manual;
  - Overloading;
  - Use of unsuitable material;
  - The effects of a chemical or electrolytic reaction;
  - Other reason beyond the control of Van der Ende Group;
- In terms of liability we apply article 13 of the Metaalunie conditions;
- If no defects are found in the product, which leads to a factory warranty, a minimum of €78,50 will be charged for inspection costs, as well as the applicable transport costs.
